



RULES AND REGULATIONS

1. Introduction

This event is a Motorized Treasure Hunt (the Event) and is organized by **INSTITUTE OF MARKETING MALAYSIA** (the Organizer). The event will be held in the Klang Valley on Saturday, 16 December 2017.

This is the second time IMM is organizing this event for its members and business associates to promote a unique outdoor intellectual activity.

2. Treasure Hunt Day

Saturday, 16 December 2017. **Duration of Event:** 7 hours (8am to 3pm)

3. Participation and Entry Fees

Participation is open to all IMM members, family and friends. A team should consist of 4 persons. All participating vehicles must possess valid road tax and insurance for use on public roads. Drivers of participating vehicles must possess valid driving license.

Entry (maximum 4 persons to a team/vehicle)

Fees

- Non-IMM Members : RM200.00 per participant
- IMM Members : RM150.00 per participant (membership must be updated and current)

4. Eligibility of Vehicles

Vehicles for this hunt cannot carry any trade plate. Participants must have adequate knowledge of their vehicles and should be able to present the vehicles for an inspection, if necessary, before the start of the event.

5. Insurance and Indemnity

The organiser and sponsors cannot be held responsible for any accident that the participants or vehicles may be involved in during the event or for violation of traffic rules and regulations by the participants.

Participants are fully responsible for the safety of themselves and their families or relatives and friends, and cannot make any claims against the organiser, sponsors or other officers.

Driver must be in possession of a valid insurance policy that covers them against third-party liability. Drivers, navigators and passengers must sign the indemnity form attached to the entry form before the start of the hunt.

6. Rights of the Organizer

The Organizer retains the right to:

- Refuse any entry of a vehicle which is not road worthy or does not have the necessary valid road tax or insurance and/or any participation of any person without a valid driving licence.
- Deny participation of any person felt to be unsuitable for participation for health reasons, deformity or instability due to being under the influence of alcohol or drugs.
- Dismiss any participant who brings along additional passengers whose names have not been entered in the entry form.
- Abandon, cancel or postpone the Event in the event of unforeseen circumstances.

Participants are to note that the decision of the Organizer in any matter pertaining to the Event is final. No protest or claim of any kind will be entertained under any circumstances.

7. Route

Navigation will be described by Route Sheets handed at the start of the event. The Route Sheets will take the form of TULIP type. All distances will be in kilometers.

8. Prizes

There will be CASH prizes and AIR TICKETS for the top three-(3) teams and other prizes for all participating teams.

9. Official Briefing - All participants MUST be present.
